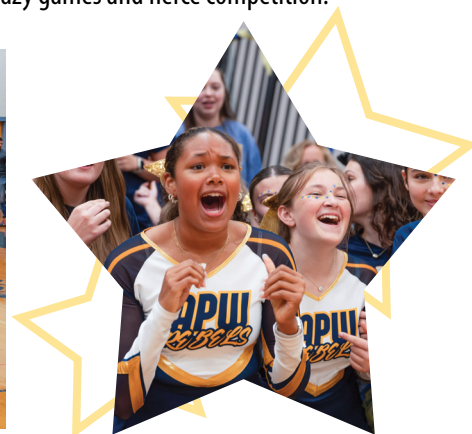
4. *What are your plans after college?*

APW Elementary School recently launched a new monthly assembly centered around the Positive Behavioral Interventions and Supports (PBIS) framework.

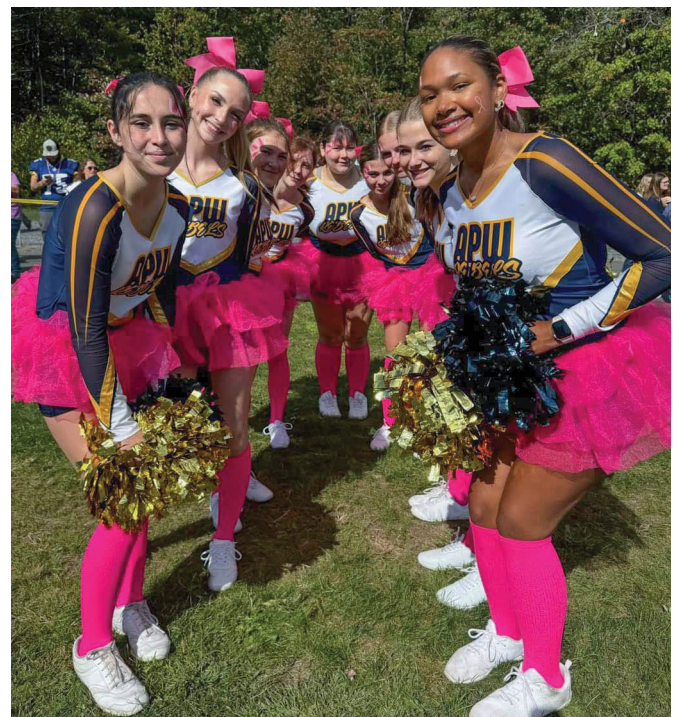

Pesticide Notification

Dear Parents, Guardians, and School Staff:

New York State Education Law Section 409-H requires all public and nonpublic elementary and secondary schools to provide written notification to all persons in parental relation, faculty, and staff regarding the potential use of pesticides periodically throughout the school year, on school property.

Schools must also advise parents and staff members that they have the right to ask to be informed 48 hours before the application of pesticides (with specific exceptions, as listed below) and that the APW Central School District is required to maintain a list of persons in parental relation, faculty, and staff who wish to receive 48-hour prior written notifications.

The following pesticide applications are not subject to prior notification requirements:

- a school remains unoccupied for a continuous 72-hours following an application;
- anti-microbial products;
- nonvolatile rodenticides in tamper resistant bait stations in areas inaccessible to children;
- nonvolatile insecticidal baits in tamper resistant bait stations in areas inaccessible to children;
- silica gels and other nonvolatile ready-to-use pastes, foams, or gels in areas inaccessible to children;
- boric acid and disodium octaborate tetrahydrate;
- the application of EPA designate=d biopesticides;
- the application of EPA designated exempt materials under 40CFR1 52.25;
- the use of aerosol products with a directed spray in containers of 18 fluid ounces or less when used to protect individuals from an imminent threat from stinging and biting insects including venomous spiders, bees, wasps, and hornets.

In the event of an emergency application necessary to protect against an imminent threat to human health, a good faith effort will be made to supply written notification to those on the 48-hour prior notification list.

Asbestos Management Plan

As provided under the Asbestos Hazard Emergency Response Act, the Altmar-Parish-Williamstown Central School District hereby makes known the steps it has undertaken to comply with AHERA and the availability of asbestos management plans.

Beginning in 1989, all district owned facilities were inspected for asbestos and management plans were developed for each building according to the requirements of AHERA. Triennial reinspection's are conducted every three years. Onondaga-Cortland-Madison BOCES of Syracuse, NY completed the 2019 AHERA Triennial inspection and update to the asbestos management plan.

Periodic Surveillance of asbestos containing building materials is conducted every six months.

All custodial and maintenance staff have undergone 2-hour Asbestos Awareness Training and provided appropriate instruction.

All response actions taken are within federal and state guidelines.

Limited amounts of asbestos-containing materials remain within the High School. Friable materials are generally inaccessible to students and staff members. Appropriate measures have been implemented to ensure the materials are not disturbed.

Annual Fire Inspection Notification

Notice is hereby given that the annual fire/safety inspection of the school buildings of the APW Central School District for fire hazards which might endanger the lives of students, teachers, and employees therein, has been completed and the report thereof is available at the district office of APW Central School District for inspection by all interested persons.

As a direct result of staff safety awareness and due to the constant, diligent attention given to safety concerns on a day-to-day basis, the fire/safety inspection report was excellent and the fire inspector was impressed with the outstanding condition of our buildings.

APW proudly represents New York as sole Ocean Guardian School at Lake Ontario's National Marine Sanctuary Dedication

Representing the only Ocean Guardian School in New York, APW's Conservation Club recently attended the Lake Ontario National Marine Sanctuary Dedication Ceremony, held at the William S. Cahill Pier in Oswego.

Invited by the National Oceanic and Atmospheric Administration (NOAA), club members joined government officials, community members, and NOAA representatives to celebrate this historic occasion.

The designation of Lake Ontario as the 19th Marine Sanctuary in the United States —and the first in New York waters — signifies a commitment to preserving its rich maritime history. According to NOAA, the sanctuary encompasses Eastern Lake Ontario and consists of "an extraordinary collection of 41 known shipwrecks and one known submerged aircraft, among the best preserved in the world."

Led by advisor Jessica Halsey, the APW Conservation Club has been dedicated to promoting environmental stewardship through school and community-based projects. Their commitment to protecting local watersheds, oceans and marine sanctuaries has earned them designation as an official NOAA Ocean Guardian School for the fourth year in a row.

Halsey expressed hope that Lake Ontario's new status as a National Marine Sanctuary would inspire more New York schools to join the Ocean Guardian School program. "Our presence at this ceremony is to show local districts the positive impact this program can have," she said. "We're teaching our youth to be responsible environmental stewards while directly contributing to the preservation of our local watersheds."

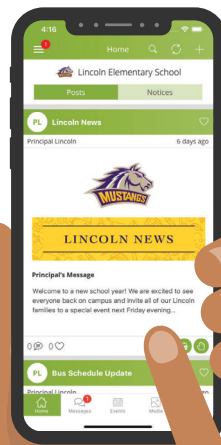

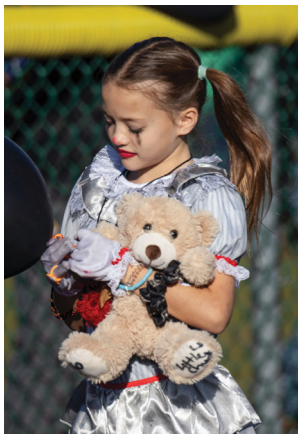
